Under the FFCRA, certain employers with fewer than 500 employees provide paid sick and family leave to employees unable to work or telework. Recommends six extensions to the ISO standard which will increase the business value of bitemporal data. Points towards a tritemporal future for bitemporal data, in which an Aristotelian ontology and a speech-act semantics support the direct management of the statements inscribed in the rows of relational tables, and add the ability to track the provenance of database content to existing bitemporal databases. This book also provides the background needed to become a business ontologist, and explains why an IT data management person, deeply familiar with corporate databases, is best suited to play that role.
